


**Re Chapter 7: Narwal Family Vehicles**


Pursuant to Section 655 of the *Criminal Code of Canada*, I, Robert H. Wright, Q.C., Counsel for the Crown, E. David Crossin, Q.C., Counsel for the accused, Ripudaman Singh Malik and Richard C.C. Peck, Q.C., Counsel for the accused, Ajaib Singh Bagri, hereby admit the following facts for the purpose of dispensing with proof thereof:

1. The copies of the motor vehicle records, attached at Tab 1 of these Admissions, (the "MV Records") establish that between June 20<sup>th</sup> 1985 and June 26<sup>th</sup>, 1985, (the "Relevant Period"), Avtar Singh Narwal owned a white 1979 Ford pick up truck and a blue 1981 Chevrolet Malibu, Gurmej Kaur Narwal owned a red 1980 Pontiac Phoenix, and Sukhwinder Singh Narwal owned a black 1982 Yamaha motorcycle.
2. The MV Records establish that during the Relevant Period, the insurance status of each of the vehicles was as follows:
  - a. the red Pontiac Phoenix was insured and licenced for use;
  - b. the black Yamaha motorcycle was insured and licenced for use; and
  - c. the white Ford pick up truck was insured and licenced for use.

3. The MV Records establish that Avtar Singh Narwal transferred the Blue Chevrolet Malibu's licence and insurance to the white Ford pick up on June 20<sup>th</sup>, 1985. He paid a fee of \$6 and a tax of \$84, for a total payment of \$90 for this transfer. On June 27<sup>th</sup>, 1985, Avtar Singh Narwal transferred ownership of the blue Chevrolet Malibu to Gurmej Kaur Narwal, who reinsured and relicenced it that same day.
4. In 1985, Temporary Operator Permits ("TOP's") were available for a fee through the Motor Vehicle Branch, to allow the operation of vehicles without the usual licencing or insurance documents.
5. Prior to 1991, the Motor Vehicle Branch issued TOP's, but records documenting the issuance of TOP's have not been retained, and are therefore unavailable.
